The Return was not completed accurately when submitted for audit. Section 1, Box 2, the annual precept, does not agree to the figure notified to us by the precepting authority. The figures in Boxes 2 and 3 should read £20420 and £55804 respectively. All grants, including council tax support grant must be shown in Box 3 as set out in the guidance on the Return.
